Boasting an industry leading 1300 lb capacity, the SJIII 4620 also features a stowed height of only 77", for easy transport and access through some low overhead doors.

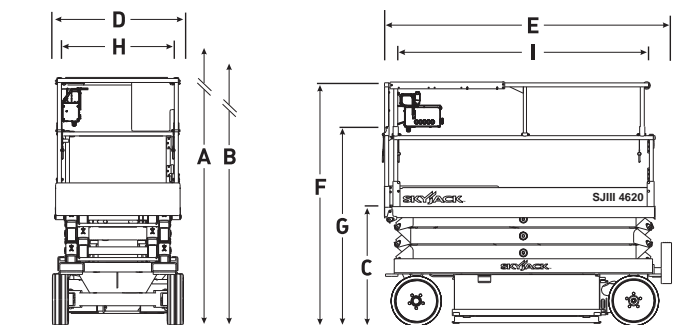
A standard 4' roll out extension deck can be secured in multiple positions, and all three models can be driven at full height.
